## **Summit Demographics**

In 2000, US Census Bureau counted 7,900 households, 5,400, paying real estate taxes directly, while 2,500 households paid these taxes indirectly thru monthly rent payments. In the census year there were 4,550 children. Currently, there are 3,650 children enrolled in public schools. Allowing for growth since the last, it is estimated about 900 attend parochial or private school. No one knows for sure how many families use our schools, but it is estimated about 25-30% maximum.

At the census date, 2,050 households contain at least one individual 65 years or older. This 26% of total households is approximately the same size as are in the public schools population. Schools are clearly our # 1 community asset, but now command more than 50 % of our tax dollars. The total burden of schools + city + county will be \$12,570. on average household this year. It is a burden many of our taxpayers can no longer afford. This is another 7 % increase, twice the rate of inflation. These large increases year after year prohibit young families from moving to Summit, and force senior citizens to leave their beloved hometown. These two segments of the population offer the diversity that Summit desires to maintain.
